Virtual AGM attendance and participation

The AGM Virtual Meeting Guide is available on the NRMA website at mynrma.com.au/agm and provides information on how to attend and participate. You will be able to test your web browser from 10.30am (Sydney time) on the day of the AGM to ensure that you can see and hear proceedings.

Members who would like to ask a question or make a comment verbally at the AGM should contact MUFG Corporate Markets on 1800 990 363 or +61 1800 990 363 beforehand to be verified as a member, obtain a unique code and be provided with the telephone number to call from 10.30am (Sydney time) on the day of the meeting.

Members who want to ask a question or make a comment will be placed in a queue to participate at the appropriate time during the AGM as determined by the Chair.

Conduct of the AGM

Under the Corporations Act 2001, the Directors are required to lay before the meeting the Financial Report, Directors' Report and Auditor's Report for the financial year ended 30 June 2025. No resolution is required for this item of Ordinary Business. The Chair will give members a reasonable opportunity to ask questions about, or make comments on, the business of the AGM or the management of the NRMA.

The Auditor will be in attendance to address members' questions about the conduct of the audit, the Auditor's Report, the accounting policies adopted by the NRMA in relation to the preparation of the Financial Report, and the independence of the Auditor in relation to the conduct of the audit.

The Chair will exercise their powers as the Chair of the meeting to ensure it is conducted in an orderly, courteous and timely fashion, in the interests of members.

Appointment of proxy

A member who is entitled to attend and vote at the AGM has the right to appoint a proxy to attend and vote on their behalf. A proxy need not be a member and may be an individual or a body corporate.

As there are no resolutions for members to vote on at the AGM, a proxy form has not been provided. However, if you wish to appoint a proxy you can do so:

Dear members.

On behalf of my fellow Directors, I am pleased to invite you to the 2025 Annual General Meeting.

We're proud to be Australia's largest mutual and over the last year we've seen membership grow to 3.4 million members across Australia. Our roadside assistance business has responded to a call for help on average every 30 seconds, and our amazing patrols rescued more than 620 children from locked cars. We're working hard on My NRMA Rewards and the My NRMA app to create value for our members on the road, when they travel, and through a world of experiences. Our spectacular Parks and Resorts continue to grow in popularity, with members spending over 700,000 nights with us.
